- 4. As per the Initial Public Announcement, the objective and rationale for the Delisting Offer is as follows:
 - a. The proposed delisting is in the interest of the Public Shareholders as it will give them an opportunity to liquidate their shareholding in the Company, at a price determined in accordance with the SEBI Delisting Regulations, providing immediate liquidity;
 - b. To obtain full ownership of the Company, which will provide the Acquirers with increased operational flexibility to support Company's business; and
 - c. To save ongoing substantial compliance costs which includes the cost associated with listing of equity shares such as annual listing fees or such other expenses required to be associated with the continued listing, which can be refocused on the Company's Business.

- 5. Pursuant to the Initial Public Announcement received from the Acquirers, the Board of Directors of the Company at its meeting held on June 03, 2024, took on record the Initial Public Announcement and Due Diligence Certificate submitted by CS Santosh Kumar Tibrewalla, Practicing Company Secretary (Peer Review Certificate No. 1346/2021; Membership No: 3811; CP No. 3982) in accordance with Regulation 10(3) of the SEBI Delisting Regulations. Pursuant to perusal of the Due Diligence Report dated June 03, 2024, and the Share Capital Audit Report under Regulation 76 of the Securities and Exchange Board of India (Depositories and Participants) Regulations, 2018, the Board of Directors approved the Delisting Proposal in terms of Regulation 10 of the SEBI Delisting Regulations, subject to approval of public shareholders of the Company. The outcome of the meeting of the Board of Directors of the Company held for approving the Delisting Offer was notified to the CSE on June 03, 2024.
- 6. While considering the Delisting Proposal, the Board, based on the information available with the Company and the Due Diligence Report, in accordance with Regulation 10(4) of the SEBI Delisting Regulations, certified that:
- The Company is in compliance with the applicable provisions of the securities laws;
- Mr. Sanjay Kumar Todi ("Acquirer 1"), Mrs. Archana Todi ("Acquirer 2"), Mrs. Sarla Devi Todi ("Acquirer 3") and M/s Madhva Textile Processors Pvt. Ltd. ("Acquirer 4") (hereinafter collectively referred to as "the Promoter Acquirers"/"Acquirers") and their related entities are in compliance with the applicable provisions of securities laws in terms of Due Diligence Report and are also in compliance with Regulation 4(5) of the SEBI Delisting Regulations; and
- The Delisting Proposal is in the interest of the shareholders of the Company.
- 7. The Board also took on record the Valuation Report dated May 31, 2024 received by the Company from the Acquirers and issued by SKP Securities Limited, SEBI Registered Category-1 Merchant Banker (Reg. No.: INM000012670) informing the Company that the Floor Price of the Delisting offer is Rs. 73.15/- (Rupees Seventy Three Point Fifteen) per equity share which is determined in accordance with Regulation 20(2) of the SEBI Delisting Regulations read with Regulation 8 of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("SEBI Takeover Regulations"). Further, as per the provisions of Regulation 35(2) of SEBI Delisting Regulations, the Acquirers has to decide an exit price in consultation with the Manager to the Delisting Offer.
- 8. Pursuant to the above, the Acquirers in consultation with the Manager to the Delisting offer and in the best interest of public shareholders have decided the exit price of Rs. 73.15/- (Rupees Seventy Three Point Fifteen) per equity share which is equal to the Floor Price determined in terms of Regulation 8(2)(e) of SEBI Takeover Regulations.
- 9. The Reference Date with respect to the computation of Floor Price for the proposed delisting is June 03, 2024 i.e., date on which the stock exchange was notified of the board meeting in which the delisting proposal was considered and approved.

- 10. In terms of Regulation 11(1) of SEBI Delisting Regulations, the Delisting offer requires approval of the shareholders of the Company by way of a special resolution by means of postal ballot through remote e-voting in accordance with the SEBI Delisting Regulations. As per regulation 11(4) of SEBI Delisting Regulations, the special resolution passed by the members of the Company shall be acted upon if the votes cast by the public shareholders in favour of the Delisting offer is at least two times the number of votes cast by the public shareholders against it.
- 11. In the event that this special resolution is passed by the members as set out above, subject to receipt of In-Principal approval of the CSE and other applicable statutory approval as may be deemed necessary from time to time, the Acquirers along with other constituents of Promoter and Promoter Group in accordance with the SEBI Delisting Regulations will dispatch offer letter to all public shareholders.
- 12. The Acquirers shall not proceed with the Delisting offer, unless consent of public shareholders is received in accordance with Regulation 35(2)(d) of SEBI Delisting Regulations and have obtained all the necessary regulatory and statutory approvals as may be required under applicable laws including the SEBI Delisting Regulations.

The Board recommends the special resolution and places it for consideration and approval of shareholders of the Company.

None of the Directors, Managers, Key Managerial Personnel and their relatives, in any way, is concerned or interested in the resolution except to the extent of their shareholding/shareholding of their associates as Promoters / Promoter Group in the Company.
